(c) Provide a transcription record of the proceedings of each hearing of the Board in accordance with these rules and keep minutes of the proceedings of each meeting held by the Board and enter therein such resolutions and orders as are adopted by the Board;(d) Cause to be mailed or otherwise delivered or made available to each member of the Board and the professional consultants to the Board, true copies of the minutes and other documents and materials pertaining to the business of the Board;

(e) Perform such other duties as normally appertain to the office of Secretary of the Atlantic City Municipal Utilities Authority and (subject to the direction of the ACMUA Executive Director) assign such parts of such duties as may be appropriate to an assistant or designee.

(f) The Board (and/or the ACMUA Executive Director) may assign such other duties as it shall deem necessary and appropriate from time to time.
