Any matter which, by express provision of Federal Law, State Statute or Rule of Court shall be rendered
confidential or excluded from discussion of public (Provision);
Any matter in which the release of information would impair a right to receive funds from the federal
government;
Any matter the disclosure of which constitutes an unwarranted invasion of individual privacy;
Any collective bargaining agreement, or the terms and conditions of which are proposed for inclusion in
any collective bargaining agreement, including the negotiation of terms and conditions with employees for
representatives of employees of the public body (Specify contract: negotiations with bargaining units);
Any matter involving the purpose, lease or acquisition of real property with public funds, the setting of
bank rates or investment of public funds where it could adversely affect the public interest if discussion of such
matters were disclosed;
☐ Any tactics and techniques utilized in protecting the safety and property of the public provided that their
disclosure could impair such protection;
Any investigations of violations or possible violations of the law;
Any pending or anticipated litigation or contract negotiation in which the public body is or may become a
party.
Any matters falling within the attorney-client privilege, to the extent that confidentiality is required in
order for the attorney to exercise his ethical duties as a lawyer (If contract negotiation the nature of the contract

such time that the matter is concluded or the circumstances no longer present a potential impact);
Any matter involving the employment, appointment, termination of employment, terms and conditions
of employment, evaluation of the performance, promotion or disciplining of any specific prospective public officer
or employee or current public officer or employee employed or appointed by the public body, unless all individual
employees or appointees whose rights could be adversely affected in writing that such matter or matter be
discussed at public meeting; Subject to the balancing of the public's interest and the employee's privacy right
under South Jersey Publishing, 124 N.J. 478, the employee(s) and nature of discussion is
Any deliberation of a public body occurring after a public hearing that may result in the imposition of a
specific civil penalty upon the responding party of the suspension or loss of a license or permit belonging to the
responding party as a result of an act of omission for which the responding party bears responsibility;

BE IT FURTHER RESOLVED that the DIRECTORS hereby declare that its discussion of the aforementioned subject(s) may be made public at a time when the Solicitor advises the Board that the disclosure of the discussion will not detrimentally affect any right, interest or duty of the ACMUA or any other entity with respect to said discussion.

No. 22-169 CITY AUCTION OF DISTRESSED PROPERTIES

BY ALL MEMBERS OF THE BOARD:

WHEREAS, the City of Atlantic City (hereinafter the "City") has organized an auction of City- Owned real estate to be held September 14, 2022, and

WHEREAS, among the distressed properties offered for sale are parcels which carry ACMUA charges for past due, unpaid quarters and will carry re-connection fees, and

WHEREAS, the City has represented to the ACMUA that the ability to sell properties at auction and to have them rehabilitated by future purchasers has been hindered by past due fees to be satisfied before re-connection for water service, and

WHEREAS, in a prior Resolution No. 53 of April 2021, the ACMUA waived such fees that were logged against properties the City sold at auction in December of 2019, and

WHEREAS, the City and the ACMUA recognized the mutual benefit of moving such distressed properties onto the tax rolls, and to enable the ACMUA to acquire new customers for these unproductive properties, and

WHEREAS, upon closer examination of procedure, it has been determined that such past due fees and re-connection charges are required to be filed as liens with the City Tax Collector, and

WHEREAS, such charges for the properties under the upcoming City auction were not filed as liens as subscribed,

NOW THEREFORE, the properties sold at the City auction on September 14, 2022 shall be exempt from payment of ACMUA fees/charges incurred prior to the aforesaid auction purchase.
