- 1 to thank him anyway pubically, so that's good.
- Okay, guys. All right. Thank you.
- 3 We're going to be moving on now to committee
- 4 reports. The engineering committee did not meet
- 5 this month. We're trying to get another alternate
- 6 date. Ms. Johnson will get back to us. However,
- 7 we'll have some engineering reporting very shortly,
- 8 but let's go into personnel committee.
- 9 Other than new hires, do we want --
- 10 is there anything you want to say, Mr. Armstrong or
- 11 Mr. Dedar?
- MR. ARMSTRONG: We -- we didn't have
- 13 a meeting also.
- 14 CHAIRMAN HILL: Okay.
- MR. ARMSTRONG: We had rescheduled,
- 16 but we can discuss it in closed session --
- 17 CHAIRMAN HILL: Okay.
- 18 MR. ARMSTRONG: -- with respect to
- 19 the new hires.
- 20 CHAIRMAN HILL: Okay. Very good.
- So we're going to move on to the
- 22 executive director's report, which the personnel
- 23 matter, of course, we're going to move into
- 24 executive session.
- 25 Let's move forward from there. The



- 1 deputy --
- 2 MR. ARMSTRONG: I only have one
- 3 public thing to say that can be stated in public.
- 4 CHAIRMAN HILL: And this --
- 5 Go ahead.
- 6 MR. ARMSTRONG: Because it wasn't --
- 7 it wasn't something prepared -- that you know and
- 8 you prepare for an agenda, but I sent an email
- 9 around about the shooting, the building being
- 10 struck.
- 11 CHAIRMAN HILL: Yeah. Yes.
- 12 MR. ARMSTRONG: For those like Wes
- 13 and the engineers who don't know, we walked in
- 14 during the -- Monday morning, and there was debris
- 15 all over the upstairs conference room floor, and it
- 16 turned out to be as a result of a gunshot that came
- 17 through the wall, hit the conference room table, and
- 18 splattered all over the floor. Further inspection
- 19 outside, I learned that the upper part of the
- 20 building was struck, as well.
- 21 And the police were called. They did
- 22 an investigation, but the ShotSpotter never picked
- 23 the -- the gunfire up. It didn't occur while anyone
- 24 was present in the building luckily, but they
- 25 weren't -- were not able to identify the time



- 1 because the ShotSpotter did not pick it up so that
- 2 we could look on the camera and determine where it
- 3 came from.
- 4 And the reason why I bring it up is
- 5 because, you know, we've had discussions in the past
- 6 about the safety and security in the neighborhood,
- 7 and one of the reasons why we wanted to keep the
- 8 front doors closed was because of some recent
- 9 activity in the neighborhood and some security
- 10 concerns that we had, not just COVID.
- 11 This is probably the fourth, fifth
- 12 shooting that I've heard of since I've been here in
- 13 the last --
- 14 CHAIRMAN HILL: Yep.
- 15 MR. ARMSTRONG: -- two and a half
- 16 years.
- 17 CHAIRMAN HILL: Yep.
- 18 MR. ARMSTRONG: Two have occurred
- 19 during the day while present -- actually, three
- 20 during the day while present, and two have occurred
- 21 at night. So safety is starting to be a pretty big
- 22 concern here.
- 23 And, you know, we've had some
- 24 security concerns about terroristic -- potential
- 25 terroristic threats, but we haven't really addressed



- 1 these kind of local domestic security concerns that
- 2 seem to be on the rise.
- 3 So at some point, I think that we
- 4 have to address how we make employees feel a little
- 5 bit more comfortable because I understand a couple
- 6 years ago someone was actually killed right outside
- 7 a window here in the street and the bullets entered
- 8 the building, and -- and an employee guit over it
- 9 because she was concerned about her safety.
- MR. WARD: Uh-huh.
- MR. ARMSTRONG: So it's -- I don't --
- 12 I'd like to get ahead of it and start to address how
- 13 we can make this building a little safer.
- One of the ways to do so is the
- 15 police have indicated that if we change the camera
- 16 system, even though we just spent a lot of money for
- 17 the camera system that we have, they -- according to
- 18 the IT department at the City, that camera system
- 19 was outdated when we bought it, that if we move to a
- 20 more advanced camera system, that the police
- 21 department could assist us in monitoring this
- 22 building automatically through AI and that AI would
- 23 be able to even identify suspects and notify us that
- 24 a potential fugitive or suspect is outside our
- 25 building or even be able to identify a person



- 1 holding a weapon, not just necessarily a gun. It
- 2 could be a knife. It could be a stick. But the AI
- 3 would put us on alert of a potential threat outside
- 4 the building, so we would have the eyes of the
- 5 police, as well as the latest technology helping or
- 6 assisting us in being aware of any potential threat
- 7 outside of the -- the building in addition to the
- 8 ShotSpotter.
- 9 One of the things we probably have to
- 10 do, too, is determine why the ShotSpotter failed. I
- 11 mentioned that to the police officers, and they said
- 12 they were going to look into it because I think that
- 13 that's helpful to us. If there's gunfire in the
- 14 past, the police respond extremely quickly when that
- 15 gunfire went off. I mean, within two or three
- 16 minutes you -- we were just surrounded by police
- 17 officers, so I'd like to know that that is working
- 18 to give employees some comfort zone, as well.
- 19 And we can consider -- as much as
- 20 this may sound out of the norm, is replacing the
- 21 glass with bulletproof glass unfortunately because
- 22 it's a realistic threat now, you know, to this --
- 23 this building has been hit by gunfire --
- 24 CHAIRMAN HILL: Yeah.
- 25 MR. ARMSTRONG: -- four times in the



- 1 last year alone. Two bullets --
- 2 CHAIRMAN HILL: A couple years ago --
- 3 a couple years ago the boardroom was hit, too.
- 4 Uh-huh.
- 5 MR. ARMSTRONG: So that's -- so
- 6 that's three times. Yeah. And also, a bullet
- 7 missed -- last year a bullet missed an employee when
- 8 it hit the building when he was putting -- changing
- 9 a trash bag.
- MS. JOHNSON: Uh-huh.
- MR. ARMSTRONG: And, you know, so
- 12 it's something we just should consider, you know, in
- 13 terms of if it's time to change the windows, maybe
- 14 just consider changing them with some sort of safety
- 15 glass, you know -- you know, just understanding the
- 16 environment that we find ourselves in.
- 17 MR. WARD: Yeah. Mr. Armstrong, just
- 18 to add to the incidents, there was a shooting of
- 19 some young people across the street at the Cedar
- 20 Market, and the kid ran across the street after he
- 21 was shot and he actually died on our property.
- MR. ARMSTRONG: Uh-huh.
- 23 Unfortunately, every time I raise this, somebody
- 24 tells me a new story I never heard before. I tell
- 25 you, it's a shame, and you know, I even -- one of



- 1 the things we may even want to consider is, you
- 2 know, to gate the place in in a more secured way,
- 3 you know, too, so that no one's able to, you know,
- 4 come on to the property even from the street. If --
- 5 because I think it's more difficult to relocate.
- 6 I mean, the first conversation
- 7 throughout the building is -- is moving the building
- 8 to someplace else. I don't know if that's a
- 9 possibility, but if we're having discussions with
- 10 I-bank right now about building the plant, which
- 11 is -- I'm going to get into, as well, at some point
- 12 in closed session. I want to give you an update on
- 13 that -- we should maybe have a conversation, too,
- 14 about the possibility if we have to relocate,
- 15 relocating, as well, the distribution center for
- 16 safety reasons.
- 17 CHAIRMAN HILL: Okay. Thank you for
- 18 the update. Very alarming. It's -- and we've been
- 19 talking security issues for quite a while.
- MR. ARMSTRONG: Right.
- 21 CHAIRMAN HILL: Yeah. So...
- 22 All right. We're going to move on to
- 23 the engineering part. This is where Remington can
- 24 maybe lead us in the engineering report and the
- 25 operations report.



- 1 There was an operations report
- 2 submitted by Ms. Johnson. It's very long, but
- 3 again, that operations report, it's the project
- 4 report, so to speak, is really helpful to me because
- 5 it shows where we are, what we're doing, how much,
- 6 and -- or how much overruns, and that's very, very
- 7 helpful, at least for me, so I would urge other
- 8 board members to review that at least.
- 9 So --
- MR. WARD: Mr. Chairman --
- 11 CHAIRMAN HILL: -- should we start
- 12 with engineering?
- MR. WARD: Mr. Chairman?
- 14 CHAIRMAN HILL: Yes.
- MR. WARD: Can you hear me? Yeah.
- 16 CHAIRMAN HILL: Yeah.
- 17 MR. WARD: Can we do number 7?
- 18 CHAIRMAN HILL: Oh, yeah. I skipped
- 19 you. Sorry, Bruce.
- MR. WARD: It's all right.
- 21 CHAIRMAN HILL: Sure. Before we go
- 22 into engineering. Sorry.
- Okay. We're going to go back up to 7
- 24 and -- before engineering. So Mr. Ward?
- 25 MR. WARD: Yeah. I had an



- 1 opportunity to reach out to Matt Edling of Sher and
- 2 Edling. They are our plaintiff's counsel for the
- 3 PFAS case. We have a major case against --
- 4 CHAIRMAN HILL: Right.
- 5 MR. WARD: -- du Pont and Dow
- 6 Chemical for the PFAS infestation that occurred in
- 7 the FAA Technical Center.
- 8 CHAIRMAN HILL: Right.
- 9 MR. WARD: So that case is about five
- 10 years old, but it is certainly moving forward, and
- 11 I'll have a better update for you on the logistics
- 12 at the next meeting.
- 13 CHAIRMAN HILL: Okay. Yeah.
- 14 That's --
- MR. WARD: But we're looking to
- 16 recover millions of dollars out of this, so...
- 17 CHAIRMAN HILL: Yeah. And nothing's
- 18 done until it's done, so...
- MR. WARD: Yep. Yep.
- 20 CHAIRMAN HILL: Yeah. Okay. Thank
- 21 you, Bruce.
- MR. WARD: Uh-huh.
- CHAIRMAN HILL: Yeah.
- Okay. Let's move on to the
- 25 engineering and operating report. So who'd like to



- 1 take the lead on that?
- MR. DENNIS: So, Gary, Ryan Hayes is
- 3 going to take the lead on just kind of touching on
- 4 the report.
- 5 CHAIRMAN HILL: Okay.
- MR. DENNIS: And, obviously, this is
- 7 the first one we've put together since Claude left
- 8 the building, so to speak, so some of these projects
- 9 were, you know -- well, all of these projects were
- 10 under Claude's purview, and we're still getting up
- 11 to speed on some of the stuff that he was working
- 12 on.
- 13 CHAIRMAN HILL: Right.
- MR. DENNIS: But Ryan will --
- 15 CHAIRMAN HILL: Okay.
- 16 MR. DENNIS: -- kind of take us
- 17 through some highlights, and then if you guys have
- 18 any specific questions, we'll be happy to answer
- 19 them.
- 20 CHAIRMAN HILL: That sounds good.
- MR. DENNIS: Okay, Ryan?
- 22 CHAIRMAN HILL: Ed, thank you.
- 23 Ryan, you're on. Just give us some
- 24 highlights I guess.
- 25 MR. HAYES: Yeah. Sure. Good



- 1 morning, everybody. Thank you for your time.
- 2 I'll -- I'll share my screen with you guys. Can
- 3 everybody see what I'm sharing?
- 4 CHAIRMAN HILL: Yep. That's it.
- 5 MR. HAYES: So I composed this --
- 6 this engineering monthly report. It was a
- 7 combination of the open contract list I -- I
- 8 received from ACMUA with construction costs and
- 9 operating contracts, as well as the report from
- 10 Claude Smith just to get everything in one place so
- 11 in the future we can add, remove closed out items,
- 12 or add comments as we go just so everything's in one
- 13 place, and then we can, you know, take it from
- 14 there.
- The table of contents, it's broken
- 16 down by type of project, as well as the contract
- 17 number for ACMUA, so it can be easily referenced as
- 18 to what project we're talking about when you read
- 19 it. So, I mean, just there's a lot of -- there's a
- 20 lot of information on this report.
- 21 A lot of these comments are left over
- 22 from Claude, and I did my best to incorporate those,
- 23 as well as any new information that I had learned
- 24 since working with the MUA. And the -- and I mean,
- 25 there's -- there's just a lot to go through.



- 1 Some of these -- some of these
- 2 projects like don't have any comments or status as I
- 3 received just the open contract list from the MUA,
- 4 and it's my hope for the future we can sit down
- 5 together more and to populate this more so it's --
- 6 so it's useful to everybody and can be distributed.
- 7 There's just a lot to -- to go
- 8 through on this. I did -- I tried my best to really
- 9 do a good job of -- of getting all the information
- 10 from -- from the staff at the MUA, the engineers
- 11 working at Remington & Vernick, as well as the, you
- 12 know, water treatment plant staff, and -- and I
- 13 mean, there's just -- you know, it's a 47-page
- 14 document. I -- I think there's a little bit too
- 15 much to go through every single item.
- 16 You know, I'm not sure how -- you
- 17 know, if somebody wants to look at specific items or
- 18 anything like that, I'd be willing to -- to go
- 19 through it like that, but -- or we could distribute
- 20 it, but I mean, if we -- like, you know, it was a
- 21 big effort just taking all of Claude's information
- 22 and compiling it, as well as, you know, the
- 23 up-to-date budgetary figures, as well.
- So that's kind of where that stands.
- 25 We can circulate it for everyone's further review



- 1 and if needed.
- 2 CHAIRMAN HILL: Excuse me, Ryan. How
- 3 do we gauge the length of a project? I know that's
- 4 hard to say. In other words, how come some of our
- 5 projects are five years, some is one year? What's
- 6 the way that we can gauge that? Do we have any kind
- 7 of timetables that we can look at?
- MR. DENNIS: So, Chairman, one thing
- 9 we could do going forward is we can establish, you
- 10 know, a rough project schedule at the outset of the
- 11 project just to give everyone --
- 12 CHAIRMAN HILL: Yeah.
- MR. DENNIS: -- some context as far
- 14 as time horizon. I do think --
- 15 CHAIRMAN HILL: Right.
- 16 MR. DENNIS: -- there are
- 17 opportunities, and we talked about this at the
- 18 engineering committee, to maybe streamline some of
- 19 the processes involved with kind of moving these
- 20 projects along. So I do think there are
- 21 opportunities to get projects done quicker, and
- 22 that's our goal, you know, more efficiently.
- 23 You know, just generally speaking,
- 24 some projects may have permitting involved that are
- 25 going to take longer. Some projects may have



- 1 outside funding sources that are involved that
- 2 could, you know, require some extra steps that could
- 3 extend the project timeline, and obviously, every
- 4 project is -- is different as far as size and
- 5 scope --
- 6 CHAIRMAN HILL: Right.
- 7 MR. DENNIS: -- and complexity. So
- 8 what we can maybe do is add to this report just some
- 9 general milestone expectations. Of course, a lot of
- 10 that is going to flex depending on how things go,
- 11 but just so that way we're not just floating and we
- 12 have some context of what -- you know, the -- kind
- 13 of the arc of the project and when we think it will
- 14 hit each milestone. That would probably be helpful.
- 15 CHAIRMAN HILL: Yeah. I think
- 16 that I'd -- I'd appreciate that at least, again,
- 17 knowing that it's flexible and there's all kinds of
- 18 issues that you guys -- that everybody hits.
- MR. DENNIS: Yep.
- 20 CHAIRMAN HILL: Because we have -- we
- 21 use a number of different contractors, as well, so I
- 22 know that's difficult.
- MR. DENNIS: Yep.
- 24 CHAIRMAN HILL: Does anybody else
- 25 have a question on their reports?



- I have one for Anita. I'm sorry.
- 2 I'm taking too much --
- 3 Anita, I was concerned about some of
- 4 the outstanding balances. Can you explain to me a
- 5 little bit how that works, where we are budget-wise
- 6 with all of that?
- 7 MS. THAPA: Yeah. Those balances are
- 8 included in the budget because the projects are
- 9 ongoing. Some of them I noticed that -- that I
- 10 had -- we have to close on our side the smaller
- 11 balances. That's why the reports are very long, as
- 12 well. Typically the contracts are for two years,
- 13 except for any other bigger projects like water main
- 14 and others --
- 15 CHAIRMAN HILL: Uh-huh.
- 16 MS. THAPA: -- those kind of
- 17 projects. But as far as the balances, those are the
- 18 balances left on the contract that the projects --
- 19 CHAIRMAN HILL: Right.
- 20 MS. THAPA: -- haven't been
- 21 completed, but obviously, it should be included in
- 22 the budget for sure.
- 23 CHAIRMAN HILL: Okay.
- MS. THAPA: Uh-huh.
- 25 CHAIRMAN HILL: Anybody else have a



- 1 question? Sorry. I took up space.
- 2 All right. Anything else from
- 3 Remington & Vernick for either the operations or --
- 4 MR. DENNIS: No. I think, like Ryan
- 5 said, you know, there's a lot on the list here.
- 6 CHAIRMAN HILL: Yeah.
- 7 MR. DENNIS: If anyone had any
- 8 specific questions regarding any specific projects,
- 9 we're happy to answer them. And as we move forward,
- 10 I think this -- we'll kind of fine-tune the report,
- 11 maybe streamline it a little bit, and get just, you
- 12 know, like we said, the schedule on there and --
- 13 CHAIRMAN HILL: Uh-huh.
- 14 MR. DENNIS: And as we kind of hit
- 15 some milestones on some of these projects, we'll be
- 16 sure to highlight those at these meetings.
- 17 CHAIRMAN HILL: Right. I think when
- 18 we -- when we meet again, engineering committee, Mr.
- 19 Eccles, then we should maybe --
- MR. ECCLES: Yes.
- 21 CHAIRMAN HILL: Maybe they can give
- 22 us a little bit more details on some of those if we
- 23 have concerns.
- Okay. Anybody else?
- Thank you. So we're going to move



- 1 on. Thank you, Remington.
- We're going to move on to our deputy
- 3 executive report. Ms. Still, I know you've been
- 4 busy with a lot of projects, the one -- the lady
- 5 with the hats. You have all of these hats that you
- 6 wear, so -- and you always look beautiful, so there
- 7 we go.
- 8 All right. Ms. Still, would you like
- 9 to give us a little update?
- 10 MS. STILL: Okay. Yeah. I -- as you
- 11 said, I've just been working on a variety of things,
- 12 have a draft RFP in place for the SCADA master plan,
- 13 so I'll be talking to Ed Jones in more detail about
- 14 that, and just picking up some of the things that --
- 15 with respect to Claude and his position,
- 16 connected -- some of the connection agreements have
- 17 to move forward, and I'm working along with R and B
- 18 with that. So it's just very busy.
- 19 CHAIRMAN HILL: Yeah. Yes.
- Okay. Accounting and financing, we
- 21 don't need to -- to vote on any of this, but it's a
- 22 great update what kind of monies are coming in,
- 23 billing, financing, shutoffs.
- Anita, would you give us a report,
- 25 please? Everything was attached.



- 1 MS. THAPA: Sure. Yes. So
- 2 financials are for the month of February --
- 3 February. As of February, the revenue from our --
- 4 from the user fees from our customers are about 4
- 5 percent more than what we budgeted, and as compared
- 6 to last year, it's about 7 percent more than the --
- 7 the year 2022, and that's obviously because we had
- 8 increased our rates. That's one of the reasons.
- 9 And as per the expenses, as of
- 10 February, we have spent 1.5 million on the operating
- 11 costs. And for the capital projects, we have spent
- 12 about 350,000. The cash management is also attached
- 13 there for the month of February. As you see, the
- 14 interest rates are about 4 percent. We are earning
- 15 about 4.5 percent in our Bank of New York trustee
- 16 account, on that one.
- 17 The balance adjustments for the
- 18 customer accounts are just for the review for -- for
- 19 the board. If you have any questions, please let us
- 20 know.
- 21 And as far as the shutoffs, we are
- 22 trying to do the shutoffs starting May 1st.
- 23 CHAIRMAN HILL: Okay.
- MS. THAPA: As we all know, the
- 25 weathers are pretty good now, so it should not be a



- 1 problem to start the shutoffs. We will be calling
- 2 the -- we had started calling the customers with the
- 3 delinquent balances.
- 4 There are a few customers that
- 5 applied for the low income water assistance program.
- 6 I took the seminar last -- I think last month.
- 7 It's -- it's amazing like how they -- you know, how
- 8 some customers are getting a lot of credit balances,
- 9 you know, big amount. Initially they were saying
- 10 that per customer, it was about 1500. I'm noticing
- 11 some customers who are, you know, at least paying
- 12 their bills on a timely manner, they are having a
- 13 credit -- now they're going to have a credit of
- 14 almost 3,000 on some of the accounts.
- So if the board member would like to,
- 16 you know, pass around this information, I believe
- 17 this assistance program will be I guess up to
- 18 September of this year. We have put it on our
- 19 website, as well. There are lots of -- I hope the
- 20 customers, you know, know about this program that
- 21 can be -- you know, that they can utilize it.
- 22 Unfortunately there's not too many customers
- 23 applied, but we're looking at this.
- 24 And this is the first-come,
- 25 first-serve, so I think they still have some chance



- 1 if they want to apply it. So if you -- like I said,
- 2 if the board member, if you want to pass this
- 3 information to our community, that would be helpful,
- 4 as well.
- 5 CHAIRMAN HILL: I -- if none of us
- 6 were busy, we could put together a -- a press
- 7 release announcing that from the MUA. I'm wondering
- 8 if we couldn't get the City -- they have a bigger
- 9 media department. I mean, maybe we should put
- 10 something -- can you -- could you put something
- 11 short and sweet like with a link thing on a press
- 12 release and then I can give it to the City to send
- 13 out? At least the -- I'd like our council members
- 14 to be aware of the program for their constituents.
- Anita, is that too much to ask, a
- 16 paragraph?
- MS. THAPA: No.
- 18 CHAIRMAN HILL: This is available.
- 19 This is what you do, blah, blah, blah, just to
- 20 help our -- our customers and our elected officials.
- 21 MS. THAPA: And some of the -- it is
- 22 the application that the customer has to, you
- 23 know --
- 24 CHAIRMAN HILL: Right.
- MS. THAPA: -- provide. We notice



- 1 some of the customers, they applied for it, but the
- 2 applications didn't complete for whatever reason --
- 3 CHAIRMAN HILL: Okay.
- 4 MS. THAPA: -- you know.
- 5 CHAIRMAN HILL: Could I -- could I
- 6 ask you or maybe Ms. Still to just work -- real
- 7 short and sweet, nothing heavy.
- 8 MS. THAPA: Sure. Yeah. Like I
- 9 said, it's on our website, too. We could just put
- 10 the information on it, and also, we also have put it
- 11 on our bills, you know.
- 12 CHAIRMAN HILL: Okay. Oh, you did,
- in the billing? You did it in the billing?
- MS. THAPA: Yeah.
- 15 CHAIRMAN HILL: Oh, okay.
- MS. THAPA: Yes.
- 17 CHAIRMAN HILL: Well, maybe if you
- 18 could still do something short, I want to make sure
- 19 all of the council members have it, so we don't have
- 20 to -- I didn't -- we didn't know about that, you
- 21 know, and they might have -- because constituents
- 22 call them quicker than they call us, so --
- Okay? And if you'd just shoot
- 24 something to me, and then I'll get it to all the
- 25 council members and to Paul or somebody up at City



- 1 Hall. Okay?
- MS. THAPA: Okay. Uh-huh.
- 3 CHAIRMAN HILL: Thank you.
- 4 Anybody else have a question on
- 5 financing or accounting?
- 6 MS. JOHNSON: No. But I do want to
- 7 ask, who is on the iPhone? It doesn't indicate
- 8 name, and it's not Mr. Banfield or Mr. Ward.
- 9 CHAIRMAN HILL: Yeah. Hello? Is
- 10 somebody calling in, public session?
- MS. JOHNSON: They're not responding.
- 12 If you see, there's a link saying iPhone.
- 13 CHAIRMAN HILL: Can you dis -- I
