Page 10 1 CHAIRMAN HILL: There you are. 2 MR. SLAWEK: Can you hear me? I had 3 difficulty to get on the -- on the camera here, 4 so... 5 CHAIRMAN HILL: No problem. We can 6 hear you. There you are. 7 MR. SLAWEK: I'm sorry. 8 CHAIRMAN HILL: Good morning. 9 MR. SLAWEK: Good morning. 10 CHAIRMAN HILL: Right. We're going 11 to go back to public participation, everybody, so -because we see Mr. Slawek is here. 12 And as I had 13 mentioned before, we know that he's working with our 14 team or we're working with him and our team for a 15 service agreement issue that we will be discussing more in closed session. 16 17 But this is public participation, Mr. 18 I know you've spoken with some people Slawek. 19 before. But would you like to address the full 20 board in public? 21 MR. SLAWEK: Yes. I would like to 22 present my case. Can I? 23 CHAIRMAN HILL: Sure. 24 MR. SLAWEK: All right. So my 25 problem is, is that -- that when I called -- when I



Page 11 submitted the applications to your guys, and then --1 2 January 4th of this year. I never have any answer 3 back 'til 60 days later. I've been talking with 4 Justin a couple of times. He doesn't provide me 5 anything. 6 Then about end of February, I start 7 getting, you know, conversations with a gentleman 8 And that's already 60 days from named Shane. 9 whenever I filed applications. We're going back and 10 forth, back and forth. 11 And it comes to the point that the 12 connection fee comes to the point that it's so much 13 money that I cannot afford to do it. And the 14 problem with this is, you know, everybody knows when 15 you do business, you have to do budgetary business. We do have another laundromat with a different 16 17 partner on 4201 Ventnor Avenue. About two and a 18 half years we pay \$6,000 to you guys to connect to 19 that line on Richmond Avenue. 20 I just don't understand why I would have to pay more than \$6,000 this time. So I don't 21 2.2 know if somebody make a mistake before at your 23 department or whoever did it, but you know, my 24 budget was done for \$6,000 to do this connection for 25 this property.



Page 12 I'm doing actually a beautiful 1 2 laundromat over there, which is essential business 3 with 32 washers, which is going to be a -- very 4 beautiful where the people are going to be able to 5 use the credit cards for payments. And it cost me a 6 lot of money to do it already. I've been having two 7 mortgages on the property, one for the building, one 8 for the machines. And I'm really in a point that, 9 you know, I can't -- I can't just pay you guys 10 whatever -- even the -- even when I talked to Shane, 11 he estimated on one run per day -- each machine was 12 like \$29,000 plus -- plus a \$5,000 to -- actually in 13 labor. 14 It's -- it's actually five feet of And the property is -- you don't even 15 pipe there. 16 have to do anything coming from the street. It's a 17 back alley. The alley is like all broke up from the 18 bricks and -- and all patched out. It's a five foot alley or six foot alley, and I'm only asking for 19 20 five foot of line upgraded from one-inch line to 21 two-inch line, which I have a service. It's not

22 like I'm actually looking to connect to a new 23 service. I do have a service, and -- and I try to 24 do things right.

You know, at this point, I don't want



25

to keep 1200 -- or 7 storage tanks in my property, 1 2 in my building to satisfy demands of these machines 3 and 1200 gallons of water going through that one-inch line when it would be much easier just to 4 5 connect, you know, a two-inch line to the building, 6 to the -- to the meter, and I'm going to go from 7 there. I'm going to go to a meter anyway with 8 two-inch line, so the problem is that, you know, 9 my -- my problem is that the day number one, when we 10 pay \$6,000, once -- once all of a sudden, when I do 11 my --12 And I put all my life savings into

13 these buildings. I've been told that now I have to 14 pay, you know, astronomical amount of money to 15 That's what actually upgrade the line to two inch. 16 is my problem honestly. Before it was 6,000 -- if 17 anybody of you gentlemen -- ladies and gentlemen 18 would be doing business and -- and you were paying 19 \$6,000 to a water company to connect it, and then 20 you open up another one, I guess your expectations 21 are the same. 2.2 CHAIRMAN HILL: Are you done, sir? 23 MR. SLAWEK: Yes. 24 CHAIRMAN HILL: Okay. Totally we --25 we understand the situation. We've had many



1 discussions, both you and I personally, as well as 2 staff.

3 Again, you -- you're well aware and 4 everybody is aware that we are -- we have to run by 5 rules and regulations. However, our rules and 6 regulations are published every end of the year. We 7 are looking at your situation, and I know we've had 8 conversations internally on what we could do to try 9 to help you out, and I think we might have come up 10 with a plan, which we'll discuss. I need to discuss 11 in closed session with our board members. 12 I know our -- our attorney Mr. Ward 13 is also on top of this because we -- we realize and

14 acknowledge that a business like you is very vital 15 to our community, and we want that to happen. We 16 applaud you for your efforts and your involvement 17 and your investment.

18 So as of this point, I'm not going to 19 say too much publicly about what the plan could 20 possibly be, but perhaps, Mr. Ward, would you like 21 to comment further? 2.2 MR. WARD: Well, we had -- in fact, 23 we had a staff meeting yesterday --24 CHAIRMAN HILL: Right. 25 MR. WARD: -- with our top staff

Page 15 people, and we understand the -- the dynamic on both 1 2 sides. 3 CHAIRMAN HILL: Right. 4 MR. WARD: Both for the authority and 5 both for the proposed laundromat. So we believe 6 that we can forge ahead in a manner that will 7 undertake our mutual interests. 8 CHAIRMAN HILL: Right. 9 MR. WARD: So we're going to speak in 10 closed session to the board. 11 CHAIRMAN HILL: Yes. 12 MR. WARD: Hopefully get the board's 13 approval of a measure that will arrive at a just 14 conclusion. 15 CHAIRMAN HILL: Right. We cannot discuss all of those details now until the full 16 17 board has heard all of that plan, Mr. Slawek. 18 Do you understand that? 19 MR. SLAWEK: I completely understand 20 it. But also, guys, realize what I was -- what I 21 had to go through here. I can't afford to put a 2.2 third mortgage on my property. 23 CHAIRMAN HILL: We understand that. MR. SLAWEK: I'm not going to be 24 25 able -- I mean, at this point, I have no choice but



Page 16 live with the storage tanks, and it doesn't make 1 2 sense for me. It just doesn't make sense. 3 CHAIRMAN HILL: Right. We're going 4 to work something out. We're going to do our best 5 to do that, and I think once the board hears some of 6 the proposals, I think we'll all be in a better 7 place. 8 So I'm going to have to suggest --9 you're welcome to stay. We're going to probably be 10 moving into closed session. We have a very busy 11 closed session, as well. But you are on the top of 12 the list of service agreements, as well as, as I 13 mentioned to our staff, we are going to be talking 14 about salary updates and adjustments. So that's 15 personnel issues, and we can't discuss that in 16 public session right now. But those are the things 17 we're going to move. 18 So if you can hold on, or if you'd 19 like to call back in, Mr. Slawek, you're welcome to 20 do so, but we're going to be leaving and then coming 21 back and giving you some answers. It's totally up 2.2 to you. 23 But my question is, this MR. SLAWEK: 24 is going to get resolved today? 25 CHAIRMAN HILL: We hope so. I would

We know 20 how -- how difficult the system is and how many 21 moving parts there are and we've had a couple of 22 managers taking some much deserved vacation and --23 and another going through some personal things that 24 are great, again, that -- that our staff has had to 25 really step up and they've done an outstanding job

KEEN: So -- so we have a few 20 water mains that need some attention this year, and 21 they coincide with the City's paving projects that 2.2 are through federal or DOT grants. So it's really 23 important for us to move on them as soon as 24 possible, otherwise we lose that opportunity for the 25 next five years, and I really don't even open --



Page 25 like opening up a road that's five years old. 1 We 2 want to wait longer if we can. 3 The first is Baltic Avenue. As you 4 know, we've been -- I bring that up. There's 5 nothing to move on or anything like that, but I 6 bring that up because when we started talking about 7 Baltic Avenue, the price for Baltic Avenue was 8 around \$5 million, but we've worked with Remington & 9 Vernick to really do some value engineering to see

10 what we need to replace, what the conditions of our 11 mains are in that road, and we've been able to 12 greatly reduce that price, and we are going to 13 replace valves and hydrants and any undersized main, 14 but we're able to leave the larger main that looks 15 like it's in great shape.

And what -- what that has done is 16 17 allowed us to open up to some of the other roads 18 that were let's say a little bit of a surprise to us 19 that they're moving so quickly on, and those are 20 South Carolina, Beach, and Gramercy Avenue, and it's 21 only a small portion of South Carolina. I can't --2.2 is it from Atlantic to Arctic? Is that right? 23 MR. SMITH: Yes, sir, Atlantic to 24 Arctic. 25 MR. KEEN: So that piece there we'll



Page 26 be able to do some work on. We have some -- some 1 2 test pits we do. We might be able to reduce the 3 scope of that project, as well. So we're going to 4 try to make sure that we're value engineering every 5 project moving forward because we know we only have 6 a certain amount of money we can spend, and if we --7 if we had unlimited money, I could probably find a 8 place to put it in the City. So we're making 9 sure --10 CHAIRMAN HILL: I'm sure you could. 11 I'm sure you could. Yeah. 12 MR. KEEN: We're making sure that 13 we're doing what's -- what's prudent for our rate 14 payers as we move forward. So Beach, Gramercy, and 15 South Carolina, they're -- I think the agenda item 16 came a little bit late, but that's a resolution we 17 had talked about at the engineering meeting. 18 CHAIRMAN HILL: Right. 19 MR. KEEN: And something that we'd 20 like Remington & Vernick to do the design and 21 inspection work for, so that's on there. 2.2 And then the other things that I have 23 on the agenda are for Florida Avenue first. I think 24 you'll remember that on that road, we had intended 25 on putting the water main in a new location, but as



Page 27 we did our test pits, we found that there were 1 2 trolley tracks through that entire section, so in 3 order to replace the main on that road, we have to 4 do it in place of where the main is now, which means 5 we need temporary services for that. 6 So we had several quotes. We tried 7 to get our staff in-house to do it, but that's not 8 going to work with the timelines and --9 CHAIRMAN HILL: No. MR. KEEN: -- the number of staff 10 11 members we have. So the best quote we had was from 12 Arthur Henry to do those temporary services. So the 20 resolution in front of you is to pay Arthur Henry 21 for work that they've done in an emergency situation 2.2 between the repair of the water main itself and then 23 the repair of the road when they're completed. 24 Go ahead. 25 CHAIRMAN HILL: A question -- a



Page 28 question which I was going to bring up at resolution 1 2 time. 3 Anita, that is already in our -- we 4 have that in our emergency fund budget? 5 MS. THAPA: So far, yes. 6 CHAIRMAN HILL: I thought -- I 7 thought so. Thank you. 8 Okay. KEEN: 23 long inside this building. So what we're looking to 24 do is, as soon as we can, come up with a -- or 25 have -- let's go to bid and come up with a



Page 29 contractor to see what the timeline's going to look 1 2 like to replace this. 3 If we can, we'll do it this year and 4 find a way to maintain ourselves with probably 5 portable air-conditioner units and fans.
