NOTICE TO BIDDERS
ADDENDUM TO BID

The Atlantic City Municipal Utilities Authority has issued Addendum No. 1 in association with the public bid advertised on August 3, 2024 for Furnishing and delivering Granulated Activated Carbon (GAC) in order to address questions from prospective bidders.

Delete in Section 4

The bid in section 4 , Bidders qualification, states that bids will only be accepted from manufacturers of bituminous coal based reagglomerated activated carbon.

Add in Section 4

Bids will only be accepted from manufacturers of bituminous coal based reagglomerated activated carbon or their appointed distributor.

Add

The winning bidder of a material that the Atlantic City Municipal Utilities Authority has not used before will be fully responsible for setting up and performing and paying for a pilot study that proves equivalency. The winning bidder will be responsible for the installation and removal of any and all apparatus or appurtenances used for the study, any tests or testing equipment associated with that study and the engineering review of the study in all phases, design, installation, implementation, removal and review. The parameters and limitations of the case study will be set by the Atlantic City Municipal Utilities Authority. For example, the Atlantic City Municipal Utilities Authority will be using GAC for more than just one type of PFOA, and therefore will need to have the ability to add different elements to the winning bidder's proposed study after they present it to the Atlantic City Municipal Utilities Authority.

Add

Each bid shall be accompanied by a certified check, cashier's check or bid bond duly executed by the bidder as principal and having as surety thereon a surety company approved by the City of Margate City in an amount not less than ten percent (10%) but in no case in excess of \$20,000.00 of the amount bid. Any such bid bond shall be without endorsement or conditions. Bid shall also be accompanied by a certificate letter from a surety company stating that it will provide the bidder with the completion bond
